

2021 Housing and Transportation Goals (SCAC)

H&T 2021 Goals
Processing goal: The Housing and Transportation Committee will quantify as many objectives as possible with percentages desired and percentages achieved.
Goal 1 Housing and Transportation (H&T) Committee will act in its <u>advisory role</u> to the SCAC.
Objective 1 By July 31, 2021, H&T Chair will provide to SCAC <u>priorities</u> to serve OC Senior Citizens in the areas of housing and transportation.
Objective 2 By October 31, 2021, H&T will provide to SCAC <u>priorities</u> for services, facilities, programs, and funding to serve the future needs of OC Senior Citizens.
Objective 3 The H&T Chair will submit a monthly summary to SCAC outlining the activities, senior trends, and areas of discussion.
Goal 2 Members of H&T Committee of SCAC will be <u>advocates</u> on housing and transportation issues facing Seniors,
Objective 1 Monthly and ongoing, the H&T Committee members will act as liaisons to their senior centers, bringing updates and information from the centers to the committee and vice versa.
Objective 2 Several members will attend quarterly OCTA Special Needs Advisory Committee (<u>SNAC</u>) meetings, as well as other individual city meetings on housing and transportation, to increase awareness and share information on housing and transportation issues throughout the County.
Objective 3 Throughout 2021, members will attend <u>Point in Time meetings</u> and report back to H&T Committee.
Objective 4 The committee will investigate the possibility of having a second pick up by the buses in later afternoon so that seniors can have more time at the centers.
Objective 5 The committee will investigate the aftermath of COVID-19 in terms of the isolation of seniors and if there are transportation possibilities to help bring seniors back into center activities.
Objective 5 The H&T liaison to the Legislative Committee will work with that committee on potential legislation regarding housing and transportation.
Goal 3 Housing and Transportation Committee will seek representation by Senior Issues stakeholders in its membership and invited guests. Increase stakeholders from appropriate professions as well as elected officials.
Objective 1 The H&T Committee will encourage members to <u>invite</u> Senior Issues stakeholders to attend the public H&T meetings.
Objective 2 The H&T Committee members will invite <u>speakers</u> to the monthly meetings to inform and update the committee as well as expose the speakers to the work of the H&T Committee.
Goal 4 H&T Committee will participate in the May 2021 Senior Summit.
Objective 1 H&T Committee members are invited and encouraged to attend the <u>Senior Summit</u> .
Objective 2 Participate in the Senior Summit with a <u>booth</u> to raise Senior community awareness of SCAC among Summit attendees.
Goal 5 The Housing and Transportation Committee will communicate and collaborate with OCSPA where appropriate.
Objective 1 Invite OCSPA to provide <u>status updates</u> as they occur.
Objective 2 Utilize OCSPA findings in the development of <u>long-term planning</u> recommendations to the SCAC.
Goal 6 The Housing and Transportation Committee will leverage communications to best serve the interest of Orange County Senior citizens.
Objective 1 Housing and Transportation speakers will focus on a central <u>theme</u> .
Objective 2 Priority will be given to H&T Meeting presentations that coincide with the national/regional awareness <u>campaign</u> for the month.
