Navigating the complexities of life is much easier with reliable resources, especially for our older adult community. We are proud to spotlight our **Information & Assistance (I&A) Call Center and Community Legal Aid SoCal**.

The I&A Call Center is staffed by caring, skilled, bilingual, and bicultural professionals who can assess situations and offer resources tailored to meet the unique needs of callers. Our database includes over 1,500 programs and resources, including Community Legal Aid SoCal.

Community Legal Aid SoCal assists older adults with a wide range of legal service needs. This includes free one-on-one legal consultation, referrals, and representation in administrative and civil cases involving consumer disputes, estate planning, conservatorships, housing issues, government benefits, elder abuse, and many other services.
